Key Updates for our Region

Connecticut

Anyone who holds an SPB license must submit their renewal to the State by April 30th. The state has extended the deadline for CEUs to 10/30/20 but you still must renew your license by the end of the month. Full Connecticut Resource page

New Jersey

As of April 10th, **construction in the State is limited** to projects already underway that meet specific criteria. Find out all the details on the New Jersey Resource page. The industry is still able to provide pool and spa maintenance including spring start-up/openings as long as you follow the revised workplace guidance.

New York

On Thursday, April 16th, we received notice from Empire State Development that **pool openings are considered an essential service** as part of the "services to ensure the safety, sanitation and general operations of the residence or building." Pennsylvania

For members working in Pennsylvania, there is a current **legislative call to action** that we ask you to take part in now. Urge your legislators to support HB 2400, which provides a waiver on the Business Closure Order to all public and private construction activities. A joint letter of support from NESPA & PHTA was sent to the House Speaker and other House leaders, urging action on HB 2400.
