This Thursday (4/30/20) is the deadline to renew your SPB license. The state has extended the deadline for CEUs to 10/30/20 but you still must renew your license by the end of the month. Full Connecticut Resource page

New Jersey

Today, Governor Murphy announced his reopening plan called the "**The Road Back: Restoring Economic Health through Public Health"**. We are advocating for construction to be part of the first businesses to reopen. We will be looking at the details of this plan and will share how our industry will be impacted by it. New York

Governor Cuomo also announced over the weekend that as May 15th approaches, he is looking at **reopening what he classifies as "low-risk" businesses like construction**. We are advocating in the State for this approach and are awaiting more details. New York Resource page.


