What is Covered	<ul> <li>This product is warranted by Saratoga Spa &amp; Bath Co., Inc., to the original retail purchaser or a one time qualified transferee of the original purchaser only. A qualified transferee shall be the next owner of the real property upon which this Saratoga inground pool step was installed. If this Saratoga Step should fail resulting from defective material and or workmanship it will be covered per the terms listed in the this limited warranty.</li> <li>This warranty applies only to steps installed in private residential pools.</li> </ul>
What is Not Covered	<ul> <li>This warranty does not cover damage, which results from your acts or acts of others, abuse, negligence, accident, act of God or normal wear and exposure to the elements. (This includes fading or discoloration)</li> <li>This warranty does not cover damage resulting from improper installation. This product must be installed according to the manufacturer's installation instructions.</li> <li>This warranty is null and void if alterations are made to the step or if accessories that can cause damage to the step are used.</li> <li>Cosmetic nonstructural hairline cracks are excluded from this warranty.</li> </ul>
What We Will Do For You	<ul> <li>We will replace or repair any pool step found to be defective. Charges for shipping, removal, installation and service calls are not covered by this warranty.</li> <li>Replacement or repair will be made within thirty (30) days, weather and conditions permitting, of confirmation of the defect and receipt of your payment, if required.</li> </ul>
How to Obtain Warranty Service	<ul> <li>If your Saratoga Spa &amp; Bath step should fail during the warranty period as a result of a problem covered by this warranty, you should notify us at our offices, in writing, at the address shown below. We will need to know your name, address, telephone number, a description of the product and defect involved, the date of installation, and the name and address of the dealer from whom you purchased the step. Also provide proof of purchase.</li> <li>Determination of the claimed defect may be made upon receipt of the step at our factory. At our option, confirmation may be made by an authorized representative at the pool site.</li> <li>All warranty claims must be made directly with Saratoga Spa &amp; Bath Co., Inc., and no merchandise is to be returned to us without prior written authorization.</li> </ul>

## **STEP SAFETY**

1. This step unit is to be installed with suitable handrail or handrails per APSP Code. If your installer is not sure how this code pertains to your installation, contact the:

Always use the handrail to assist in entering or exiting the pool by the steps, and inspect the handrail often to be sure it is secure.

2.Attach (2) "Caution – Stairs May Be Slippery" decals, as illustrated, to each side of the step unit above the water line.



- 3. Steps may become slippery when algae forms or body and suntan oils accumulate, so clean them regularly.
- 4. Do not allow pushing, running or roughhousing on or near the steps. This should not be considered a play area.
